# PET ADOPTION CONTRACT

## Terms of Agreement

A non-refundable adoption fee of \$\_\_\_\_\_ will be collected from the adopter at the time of adoption.

The Adopter agrees to keep and take good care of their pet in the most possible safe and humane manner and shall treat as a family pet and companion.

The Adopter understands that pets require to have appropriate food, water, shelter, and medical care for the duration of its life and shall ensure they are properly taken care of will nourish them to their allowed capacity.

The Adopter understands his/her responsibility to become familiar with the local or state laws relating to licensing and animal welfare and shall abide by them.

In case of an incapacity to continue to care for their pet, it shall be the responsibility of the Adopter to inform the previous owner or the animal shelter for such incapacity, and by which the former owner or the shelter shall have the right to exercise their retained Right of First Refusal in the opportunity to reclaim their pet.

The parties understand that there are no guarantees or warranties with regards to the behavior, health or temperament of their pet. Any damages or injuries caused by the actions of their pet shall be borne by the Adopter.

Adopter is aware that rescue animals often come from dire situations and can have a variety of medical and health issues. While AAOC will disclose any prior treated, witnessed or known medical, behavioral or other health conditions, Adopter accepts and adopts this pet 'AS-IS', and releases AAOC from any liability or responsibility of any future medical treatment, regardless of when the issue originated. No guarantees or promises of any kind have been made by AAOC, their employees or representatives.

The parties declare that they enter this contract voluntarily, without any hesitation or have not been induced or coerced.

In the event there is a violation of the agreement, the former owner or the shelter shall have the right to sue pertaining violations found in the local or state laws. In addition, the former owner or the shelter shall have the right to sue for damages from the breach of this agreement.

Should any of the provisions of this Agreement be held invalid, such invalidity shall apply only to the said invalid provision and the remaining provisions shall continue to remain valid and enforceable.

No modification or alteration of any part of this contract shall be considered as having been made unless executed in writing and duly signed by the parties.
